### President Shaw Steps Down

The next order of business was to vote to approve Matt Bartnicki, the current VBBA President, to be the interim VBBA President to the conclusion of the voting at the VBBA National Conference to be held in board so that there will Cooperstown, NY. ### **Information Regarding Board and Trustee Candidates**

In the Elections Issue of the Newsletter, information regarding eligibility to serve was included with candidate statements. I include the statement here, again. It should be noted that one of the requirements has been payment of team dues, the other requirement involves being a full member team

which means playing a schedule of at least 6 matches a year. To that end, the final slate is going to look a bit different than originally presented. Also, there are some candidates which need to pay dues.

Section 4. Eligibility to Serve.

"In order to serve on the Executive Board, an individual must be designated as the representative of the member club. The member club shall have satisfied the dues and membership status requirements set forth in these Code of Regulations."

Mr. Newcomb will not be on the ballot as a Trustee. Mr. Weigmann has agreed to move from being a candidate for Treasurer, to running for a position as a Trustee. An alternate candidate for Treasure has been agreed upon. Mr. Paul "Scooter" Zeledon has agreed to run for Treasurer. Below, please find a brief statement from Mr. Zeledon: "I have been an active member of the Chicago Salmon since the 2008 campaign. 
### Finally, Your Team's Help is Needed to Make Sure the Annual Silent Auction is a Success!!



### "In the Middle of the New Member Club Tenure"

My name to all my fans...which may equal 2 or 3...here in Huntsville, Alabama is "Lemon Drop." I'm the founder and self-titled Captain Emeritus of the Huntsville Vintage Base Ball Club and it's first team, the Redcaps. Planning for the HVBBC began back in March of 2014. It was a long 2 years of recruiting, organizing, paperwork, and community liaison to get going. In fact I was at a point where I'd said "to heck with it" when the VBBA contacted me in 2015 to see if we were still going to field a team.

In November of 2015 we traveled up to Spring Hill, Tennessee to play another new team in a couple of exhibition games. They were better uniformed than we were but we all had an awesome time and it solidified the desire of my team members to play vintage base ball. My point here is, practice is great, and the stories are encouraging, but until a ballist actually steps on the field and participates in a game they don't realize how fun it actually is.

We kicked off our inaugural season with a four team tourney at our home field of Lowe Mill here in Huntsville. We actually ended up winning it, which made us all very happy as the painted commemorative trophy ball would remain in Huntsville. A point to be made at this point is to get the word out...newspaper, TV, Facebook. It is estimated that for that opening tournament we had between 750 and 1000 spectators throughout the day. We decided to prepare lunch for the visiting teams, but unfortunately the food trucks that were supposed to show up for the spectators didn't show. At any rate, another recommendation is to always show as much hospitality to the visitors as possible. Admittingly the lunch we put on was a little too much and we won't repeat that. But refreshments, information on local area to visiting ballists and their families, and just good ole politeness goes a really long way.

We headed to Nashville to play in the Sam Davis Cup tournament hosted by the Tennessee Association of Vintage Base Ball. And low and behold we ended up winning that one...which was nice because it meant we already had one game scheduled for 2017. In fact, it is scheduled right now for March 19, 2017 at the Sam Davis House outside Nashville, TN. So if you're in the area, come by and watch us defend our title and meet some of the teams. "Uncle Jessie" of the Scouts of Stewart's Creek returned our hospitality and we almost lost due to the fried chicken they provided us right before the championship game.

Now many will complain of the above picture, well the sunglasses, and I concur. But here's the explanation – "Catfish" slid in just as the picture was snapped and those are medical prescription glasses he has to wear while playing due to a previous ball injury.

We ended up with a winning season, but more importantly a fun season. We were even invited by a small town in Northeast Alabama to play in their annual Mule Day Celebration on Labor Day. Throughout the season we had a good number of loyal fans. I only wish I could have had t-shirts ready to sell prior to our final home game.

Now it wasn't all roses. My biggest effort was ensuring we'd have enough players for each game, and for an inaugural season I think I tried to schedule too much. Equipment wasn't a problem other than an argument over which balls were better for game use so I'd know which to order. By the end of the season we had 5 personally purchased bats.

Another issue was how to handle all the requests of people who wanted to play. The requests numbers showed we'd have enough for a second team, and we tried that. That added some thorny times to the season and I can only blame myself for trying to go too far in order to keep people interested and grow the club. My recommendation is concentrate on the one team that first year. Ask those interested to keep coming out to watch games and make a contact roster for the following year. Then in your second season, if you still have enough interest try starting a second team. Our second team, the Spinners, ended up with 4-5 really committed players.

Also don't go too far over the minimum number of games. The reason being, no matter how motivated you are, until your players, and more importantly their families, see how much fun ya'll have they will be trying to decide between games and other events.

Order hats early...plan on at least 6 weeks for a full team order. We are blessed because the wife of one of our umpires is a seamstress and makes our uniform shirts. Encourage the wives to participate also; some of our wives and even more fans have dressed out as "Belles" and interact with the crowd. Encourage your umpires to make a persona too. One of our umpires, Harold, also works with the volunteer fire station and has created his own period correct umpire uniform.



### **Summary of Secretary Reports**

### Secretary Report Summary

The Board Meeting was called to order by Secretary Ernst, in the absence of the President. The Agenda was presented by Secretary Ernst. Seven of ten members being in attendance, a quorum was established. The Secretary called for a motion to accept the resignation of President Shaw. The Motion was made by DeGeatano and Seconded by Brooks. All in attendance voted to accept the resignation. Discussion commenced about approving an interim President. Brooks moved Vice President Bartnicki to assume the duties of President until the Election of new officers and Trustees at the National Conference in March. DeGeatano seconded the motion. A vote was taken to confirm Bartnicki, the vote was unanimous.

At that time, Interim President Bartnicki took charge of the meeting and the Board took up the business of appointing an interim Vice President. DeGeatano moved Gary Schiappacasse to fill the position of Vice President for the remainder of the term. The vote was unanimous.

President Bartnicki then called the business meeting to order. The Minutes of the November meeting were discussed and accepted without change. Brooks moved the motion to accept, Bartnicki seconded the motion. The minutes were accepted.

President Bartnicki called for the Treasurer's report. Brooks offered the report. DeGeatano moved approval, Ernst seconded the motion. The report was accepted.

DeGeatano discussed an update regarding the National Conference. Brooks asked for assurances, in writing, that the hotel would accept oral discussions regarding room registration agreement between DeGeatano and the hotel management. Other points regarding planning were discussed.

Gaskell requested the Board discuss two more clubs for the New Member Program. The South Haven Bark Peelers and the Mohican Rivermen Baseball clubs were accepted into the program with the agreement that the clubs be mentored by existing members. The meeting was adjourned. The next meeting is Feb. 19.
